



Invitation for Bids

1. Devchuli Municipality office, Pragatinagar Nawalparasi invites sealed bids or Electronic bids from eligible bidders under National Competitive Bidding procedures. Bidding is open all eligible Nepalese bidders.
2. A complete set of Bidding Documents may be purchased at office hours from the Devchuli Municipality office, Pragatinagar, Nawalparasi and "Kolenika" office Nawalparasi by eligible Bidders on submission of written application, along with duly attested copies of Firm registration, VAT registration, and tax clearance certificate (Valid for fiscal year 2072-73), Joint venture agreement (in case of JV) and upon te payment of a non-refundable fee as mentioned in the table below within the office hour on or before 2073/11/16.

Bidders who choose to submit their bid electronically may purchase the hard copy of bidding document as mentioned above or may download the bidding document for e submission from PPMO website www.bolpatra.gov.np. Bidders submitting their bid electronically should deposit the bidding document cost as nonrefundable fee of NRs. 3000.00 to the bank detail given in 4 no point and scan copy of deposit slip shall be submit along with electronics submission of bids.

5. Pre Bid Meeting shall be held at Devchuli Municipality Office, Pragatinar, Nawalparasi at 2:00PM on 2073/11/04.
6. The purchased bid document shall be submitted within deadline by sealed envelope addressing to the mentioned above office, indicating contract identification number, name of the bidder's firm and it's detail address.
The bid must be submitted at Devchuli Municipality Office on or Before 12:00 hours on 2073/11/17.
7. Bids shall be opened in the presence of Bidder's representatives who choose to attend at 14:00 hour on 2073/11/17 at Devchuli Municipality Office, Pragatinagar, Nawalparasi. Nonattendance of any or the Bidder's entire representative doesn't care for the opening of Bid.
8. Bids must be accompanied by a bid security of minimum amount specified in table below either in the form of bank Voucher conforming cash deposit in deposit account specified above or a bid security (unconditional bank guarantee) issued by "A" class commercial Bank as approved by Nepal Rastra Bank . The Bid must be valid for a period of 90 days (Ninty days) after bid opening and Bid security must be valid 30 days beyond the bid validity period. Bidder must clearly quote the contract name and contract number in bid security form (Bank Guarantee) otherwise will cause disqualification of Bidder. Bidder who choose to submit their bids electronically shall submit the scan copy of bid security amount deposit slip or Bank guarantee.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Devchuli Municipality office reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
11. Bidders are advised to visit the site and assess the actual site condition before submitting the bids at their own cost.
12. The bidders who submit the bid electronically are requested to submit all the original hardcopy document including bid document within 7 days after bid submission date at Devchuli Municipality Office, Pragatinagar, Nawalparasi.
